The Initial Application Filing Window Closes Tomorrow - Apply Now for Emergency Connectivity Fund Program Support!

The Emergency Connectivity Fund Program application filing window will be open for **1 more** day! Eligible schools and libraries **must apply by this Friday, August 13, 2021, 11:59 p.m. ET**. During the current application filing window, eligible schools and libraries, in addition to consortia of schools and libraries, can submit requests for funding to purchase eligible equipment and services between July 1, 2021, and June 30, 2022 to meet the remote learning needs of students, school staff, and library patrons who would otherwise lack access to connected devices and broadband connections sufficient to engage in remote learning.
